Description of survey:	The National Income Dynamics Study (NIDS) is the first national household panel study in South Africa. It is part of an intensive effort on the part of the government to track and understand the shifting face of poverty. The National Income Dynamics Study is implemented by the Southern Africa Labour and Development Research Unit (SALDRU) based at the University of Cape Town's School of Economics. The study began in 2008 with a nationally representative baseline sample of over 28,000 individuals in 7,305 households across the country. The survey continues to be repeated with these same household members every two years, with Wave 2 conducted in 2010/11 and Wave 3 in 2012.

The data have been inflated to the end of 2014 using official consumer price inflation (CPI) trend data produced by Statistics South Africa. In South Africa, wages typically increase by CPI plus 1%, so we have adjusted on this basis. Due to panel design of NIDS, we have relied on the Baseline Wave, since subsequent rounds are no longer nationally representative. We have nonetheless compared the income deciles produced against two other sources: (i) the third wave of NIDS (2012) and (ii) the banded household income data from the 2013 round of the South African Social Attitudes Survey (SASAS).
